



Factory Tours Visitor Release

By signing below, I agree to the following:

- Piper Aircraft, Inc. (Piper) is a smoke free facility. No tobacco usage of any kind during the tour or on Piper campus is permitted. I will refrain from using tobacco products of any kind while on Piper property.
- No photography of any kind is permitted on Piper property. I will refrain from taking any photos or videos unless explicitly instructed otherwise by my tour guide.
- The release or disclosure of any Piper Aircraft proprietary information in any manner is strictly forbidden.
- Children under the age of 10 are not permitted in the manufacturing areas. Children under 16 are required to be accompanied by an adult and must wear proper safety equipment and at all times.
- Guests must wear closed toe and heel shoes, with heel height less than 1.5 inches. I understand that if I don't meet the dress code for shoes, I may not enter the manufacturing area.
- All participants must be escorted at all times. I will remain within the designated tour path and with my designated tour guide at all times. I will abide by any instructions that my tour guide may give me.
- Safety glasses and hearing protection are provided for the tour and must be worn in designated areas. No sunglasses are permitted to be worn inside the factory at any time. I will wear the provided safety glass and hearing protection as instructed by my tour guide.
- Per Piper policy, the following are not permitted on the factory:
 - No weapons of any kind, including firearms/concealed weapons
 - No photography, audio or video recording devices
 - No backpacks or bags
 - No animals (except ADA Service Animals specially trained to assist someone with a disability)
 - No tobacco products
- I represent to Piper Aircraft that I do not have any known illness or impairment that may prevent me from observing and abiding by all rules and precautions for my own safety or the safety of others.

I ACKNOWLEDGE THAT DURING THE FACTORY TOUR I WILL BE ENTERING WORKING AREAS OF A MANUFACTURING FACILITY WHERE THERE ARE INHERENT RISKS AND BOTH KNOWN AND UNKNOWN HAZARDS THAT MAY POSE A RISK OF INJURY OR DAMAGE TO MY PERSONAL PROPERTY. BY ENTERING THE FACILITY AND TAKING THE TOUR I VOLUNTARILY ASSUME THE RISK OF ANY SUCH HAZARDS AND RELEASE PIPER AIRCRAFT, INC. AND ITS OWNERS, OFFICERS, EMPLOYEES AND AGENTS FROM ANY LIABILITY, CLAIMS, DEMANDS, AND CAUSES OF ACTION WHATSOEVER THAT MAY ARISE OUT OF OR ARE RELATED TO ANY INJURY, LOSS OR DAMAGE THAT MAY OCCUR WHILE VISITING THE PIPER AIRCRAFT FACILITY OR TAKING THE FACTORY TOUR.
