



Piper Visitor Release

Piper Aircraft, Inc. ("Piper") is committed to maintaining a safe, secure, and productive environment for all employees, visitors, and guests. All visitors must adhere to the following guidelines to ensure compliance with Piper's policies.

- **Photo ID:** I agree to present a valid, government-issued photo identification prior to being granted access to the premises. I agree that failure or refusal to provide such identification will result in denial of entry to the premises.
 - **Visitor ID Badge:** I have been granted access to Piper facilities as a Visitor. I agree to wear my Visitor ID Badge and to follow the rules governing my entrance to Piper’s facilities as follows.
 - **Escort:** All Visitors must be escorted at all times throughout the Piper facilities. I will remain within the designated areas as instructed by my Escort at all times. I will abide by any instructions that my Escort may give me.
 - **Designated Smoking Areas:** Smoking or using tobacco products is permitted only in designated smoking areas. I agree that I will refrain from smoking in all non-designated areas.
 - **Photography and Video Recordings:** Photographs and video recordings are only permitted with express permission from the Visitor’s Escort. I agree to refrain from taking any photos or videos unless explicitly permitted by my Escort.
 - **Confidentiality and Proprietary Restrictions:** The release or disclosure of any Piper proprietary information in any manner is strictly forbidden. I agree to adhere to all Piper policies for confidentiality and I agree not to enter any prohibited facilities as marked.
 - **Dress Code & Footwear Requirements:** Guests **MUST** wear shoes that cover the toes and heels at all times; i.e. no flip flops, crocks, slides, backless shoes, etc. I understand that if I do not meet the dress code for shoes, I will not be able to enter certain areas of the Piper factory.
 - **No one under 12 is permitted in the Piper factory.**
 - **Personal Protective Equipment (PPE):** Safety glasses and hearing protection are provided and must be worn in designated areas. No sunglasses are permitted to be worn inside the factory at any time. I will wear the required PPE as instructed by my Escort.
- Prohibited Items: I will not bring the following onto Piper’s property:**
- No weapons of any kind, including firearms
 - No animals of any kind – no exceptions
 - No backpacks or luggage bags; pocket books and purses are acceptable.

I have read and understand the above guidelines. By signing below, I agree to follow these guidelines. If I fail to abide by these guidelines, I understand I will be dismissed from Piper’s property and potentially barred from attendance at Piper in the future.
